Source of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pickup substances resulting from the presence of animals or from human activity.

Contaminates that may be present in source water include:

- > Microbial contaminants: such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- > Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic waste water discharge, oil and gas, production, mining, or farming.
- > Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water run off and residential uses.
- > Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- > Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population.

Immuno – compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.

EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hot Line (800) - 426-4791.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. To determine Warrensburg's susceptibility to ground water contamination, a Well Site Survey, published in 1989 by the IEPA, was reviewed. Based on the information contained in this document, six potential sources of ground water contamination are present that could pose a hazard to groundwater pumped by the Warrensburg community water supply wells. These include two below ground fuel storages, an above ground hazardous substance storage, a surface impounding, a warehouse, and a domestic waste water treatment facility. The IEPA has determined that Warrensburg Wells #2, #3, and #4 are not susceptible to IOC, VOC, or SOC contamination. This determination is based on a number of criteria including: monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and the available hydrogeologic data for the wells. In anticipation of the U.S. EPA's proposed Ground Water Rule, the IEPA has determined that Warrensburg's community water supply wells are not vulnerable to viral contamination. This determination is based upon the evaluation of the following criteria during the Vulnerability Waiver Process; the community's wells are properly constructed with sound integrity and proper site conditions; there is a hydrogeologic barrier that restricts pathogen movement; all potential routes and sanitary defects have been mitigated such that the source water is adequately protected, monitoring data did not indicate a history of disease outbreak; and the sanitary survey of the water supply did not indicate a viral contamination threat. However, having stated this, the U.S. EPA is proposing to require states to identify sites in karst, gravel and fractured rock aquifer systems as sensitive. Water systems utilizing these aquifer types would be required to perform routine source water monitoring. Because the community's wells are constructed in a confined aquifer, which should provide an adequate degree of protection to prevent the movement of pathogens into the wells, well hydraulics were not considered to be a significant factor in the vulnerability determination.

WATER QUALITY TEST RESULTS

- >Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- >Maximum Contaminant Level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- >Maximum Residual Disinfectant Level Goal (MRDLG): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants. The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- >Maximum Residual Disinfectant Level (MRDL): The following tables contain scientific terms and measures, some of which may require explanation.
 - >ppb: Micrograms Per Liter or Parts Per Billion - or one ounce in 7,350,000 gallons of water.
 - >na: Not Applicable
 - >AVG: Regulatory compliance with some MCLs are based on running annual average of monthly samples.
 - >ppm: Milligrams Per Liter or Parts Per Million - or one ounce in 7.350 gallons of water.
 - >pCi/L: Picocuries Per Liter
- Level 1 Assessment: A Level 1 assessment is the study of the water system to identify potential problems and determine (if possible) why total coliform bacteria had been found in our water system.
- Level 2 Assessment: A Level 1 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and / or why total coliform bacteria had been found in our water system on multiple occasions.
- mrem: Millirems per year (a measure of radiation absorbed by the body.
- Treatment Technique or TT: A required process intended to reduce the level of a contaminant in drinking water.
