**ORDINANCE NO. 746**

**AN ORDINANCE AUTHORIZING, APPROVING, AND  
ACCEPTING THE PROPOSAL FROM GENERAL CODE  
FOR CODIFICATION SERVICES**

**WHEREAS**, the Village of Warrensburg, Illinois Village Code (“the Code”) was originally codified in 1978 and it has not been updated since 2005; and

**WHEREAS**, the Village of Warrensburg Code may contain inconsistencies, errors or outdated information that could potentially affect the Code’s enforcibility and alignment with relevant state statutes; and

**WHEREAS**, the Village desires to complete recodification, including a comprehensive review and update of the Code, to include all legislation of a general and permanent nature; and

**WHEREAS**, the Village desires also to provide access to the Code and make it easier for constituents and staff to find information by implementing a fully searchable online version of its Code; and

**WHEREAS**, the Village has considered a number of proposals for codification services and the proposal from General Code best meets the Village’s needs.

**NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Warrensburg, Illinois:**

**Section 1.** That the proposal from General Code, dated February 25, 2020, in the sum of Ten Thousand Dollars (\$10,000.00) for codification services be and is hereby approved and accepted.

**Section 2.** That the President of the Board of Trustees and the Village Administrative Clerk, or their designees, be and are hereby authorized and approved to execute any and all necessary documents.

**Section 3.** That this Ordinance, after its passage and approval, shall be published in pamphlet form and shall be in full force and effect after such publication, in the manner, form, and time as provided by the laws of the State of Illinois.
