ORDINANCE NO. 753

**AN ORDINANCE
AUTHORIZING AND APPROVING AN AMENDED BUDGET
FOR FISCAL YEAR 2020-2021**

WHEREAS, the Village Board of the Village of Warrensburg, Macon County, Illinois, adopted an Annual Budget for the Fiscal Year 2020-2021 on April 20, 2020; and

WHEREAS, due to an oversight, the expenditure for the Central Illinois Regional Dispatch Center was not included in the Budget; and

WHEREAS, the Village is desirous of amending the Annual Budget for the period commencing May 1, 2020 and ending April 30, 2021 to include that expenditure.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS, MACON COUNTY, ILLINOIS:

Section 1:

That the Village of Warrensburg, Macon County, Illinois Budget for Fiscal Year 2020-2021 be amended as follows:

Section 2:

That as a result of the inclusion of the line item for Contract/ Macon County CIRDC, the total expenses for the Police Protection Fund increases from \$171,086.00 to \$181,086.00, and the total expenses for the Village of Warrensburg Budget increases from \$927,616.00 to \$937,616.00.

Section 3:

If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

Section 4:

That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

Section 5:

That this Ordinance shall take effect upon its passage as provided by the law of the State of Illinois, and in addition shall be published in pamphlet form and posted in not less than three prominent places within the municipality.




CERTIFICATE
