ORDINANCE NO. 765

**AN ORDINANCE AUTHORIZING AND APPROVING
THE JUNE, 2021 SCHEDULE OF FEES**

WHEREAS, the Village of Warrensburg, Illinois ("Village") did adopt a new Village Code on June 7, 2021; and

WHEREAS, the new Code referenced certain fees charged by the Village in connection with Village services as set forth in the new Code; and

WHEREAS, the Board of Trustees wishes to take formal action to approve and adopt the June, 2021 Schedule of Fees.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE PRESIDENT AND THE TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:

Section 1: The attached Schedule of Fees in connection with Village services, as set forth in the 2021 Code of the Village of Warrensburg, Illinois dated June, 2021 be and the same is hereby approved and adopted.

Section 2: This Ordinance shall be in full force and effect ten days following publication as provided by law.

Section 3: The Village Administrative Clerk of the Village of Warrensburg shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form.






