ORDINANCE NO. 767

**AN ORDINANCE AMENDING
SECTION 972-9, SECTION 972-10
AND SECTION 1388-4
OF THE VILLAGE CODE**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:

SECTION I

THAT Section 972-9 entitled “Removal; Notice” of the Village Code of Warrensburg, IL is hereby amended by deleting the words “Superintendent of Public Works” and substituting the words “ Village Administrative Clerk”, so that Section 972-9 shall read as follows:

“It shall be the duty of the Village Administrative Clerk to serve or cause to be served a notice upon the owner or occupant of such premises on which weeds or plants are permitted to grow in violation of the provisions of this article and to demand the abatement of the nuisance within 10 days.”

SECTION II

THAT Section 972-10 entitled “Violations and penalties; abatement” of the Village Code of Warrensburg, Illinois is hereby amended by deleting the word “five” in the first sentence of this Section and substituting the word “ten” to the first sentence, so that the first sentence of Section 972-10 shall read as follows:

“If the person so served does not abate the nuisance within 10 days after such notice, that person shall be deemed in violation of this article and shall be fined in accordance with Chapter 100, Article III, of the Village Code”.

SECTION III

THAT Section 1388-4 B. entitled “Penalties. Settlement”, of the Village Code of Warrensburg, Illinois is hereby amended by deleting the numbers “120” and substituting

the numbers “150” in the first paragraph, so that the first sentence of subparagraph B shall read as follows:

“B. Settlement. Any alleged offender who receives such a citation for a first offense may settle and compromise the claim against him or her for such alleged offense by paying the Village the sum of \$150 within 14 days of the date such citation was dated and received by the alleged offender.”

SECTION IV

THAT Section 1388-4 C. entitled “Penalties. Repeat Offense.” of the Village Code of Warrensburg, IL is hereby amended by deleting the entire subparagraph C and substituting in its place the following subparagraph:

“C. Repeat offense. In the event any alleged offender receives a citation accusing the alleged offender of any violation listed in this section and having received a prior ordinance violation citation for violation of either Section 1388-2 or 1388-3 within a period of 12 months, the fine for such repeat offenses shall be doubled.”

SECTION V

THAT Section 1388-4 D. entitled “Penalties. Failure to pay.” of the Village Code of Warrensburg, IL is hereby amended by deleting the entire subparagraph D. and substituting in its place the following:

“D. Failure to pay In the event the alleged offender who receives any citation fails to pay the appropriate sum as required above within 14 days, the original sum owed shall be doubled. In the event the alleged offender does not pay the aforementioned doubled sum within an additional 14 days, the Village may elect to institute a prosecution for the alleged offense involved.”

SECTION VI

THAT Sections I and II of this Ordinance, after its passage and approval, shall be published in pamphlet form and shall be in full force and effect on October 20, 2021, after such publication, in the manner, form, and time is provided by the laws of the State of Illinois.

SECTION VII

THAT Section III, Section IV, and Section V of this Ordinance, after passage and approval, shall be published in pamphlet form and shall be in full force and effect on June 1, 2022, after such publication in the manner, form, and time is provided by the laws of the State of Illinois.
