**AN ORDINANCE ESTABLISHING

NOW BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF WARRENSBURG:

Section 1: That the attached Donation Policy be and the same is hereby adopted by the Village of Warrensburg, effective January 1, 2022.

Section 2: That the Village Administrative Clerk of the Village of Warrensburg shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form, and this Ordinance shall take effect on January 1, 2022, after said publication, in the manner, form, and time as provided by the laws of the State of Illinois.






CERTIFICATE

Village of Warrensburg, IL
Donation Policy
Effective January 1, 2022

1. Purpose:

The purpose of this document is to establish parameters and procedures to be followed by the Village of Warrensburg ('Village') staff and the Village Board of Trustees ('Board') with respect to request for donations that are routinely presented to the Village.

2. Procedures:

- Request shall be presented in writing and must contain the requesting organization's name, purpose of the donation, amount being requested, and time and place if for an event.
- Proper requests will be placed on the next available meeting agenda and voted on through normal Board action. Donation requests will not be approved via special action outside of a scheduled Board meeting.

3. Parameters:

- The total amount of donations made in any fiscal year shall not exceed \$1,000 and no individual donation shall exceed \$100.
- The maximum amount that can be donated to any one organization in a fiscal year is \$200, providing there are multiple events or requests.
- Funding for the donations shall be from Gaming revenue ('Gaming') collected. The total amount of donations allowed, \$1,000, is dependent upon Gaming being at least \$5,000 per year. If Gaming drops below \$5,000 per year, Board action will be necessary to determine amount of donations to be given, if any.
- All donations provided to requesting organizations shall be for the betterment or promotion of the Village and/or the residents of Warrensburg, IL.

4. This policy shall govern the treatment of donation requests for the Village until such time that the Board takes further action to amend. Questions concerning the meaning or applicability of these parameters shall be directed to the VAC for interpretation and response.
