ORDINANCE NO. 771

**AN ORDINANCE AMENDING SECTION 332-24 A.(1)
ENTITLED "REGULAR MEETINGS", OF THE
CODE OF THE VILLAGE OF WARRENSBURG,
TO AMEND THE MEETING TIME TO 5:30 P.M.**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:

Section 1:

THAT, Section 332-24 A.(1) of the Code of the Village of Warrensburg, entitled "Regular Meetings" be and the same is hereby amended by deleting the numbers "6:00", and substituting in their place, the following numbers "5:30", so that the Section shall read as follows:

§ 332-25 Meetings

A. Regular meetings.

- (1) Regular Meetings: The Village Board shall hold its regular meetings in the Village Hall on the first and third Mondays each month at 5:30 p.m., provided that if any meeting shall fall upon a holiday, then such meeting shall be held upon the Tuesday following. Notice of such regular meetings shall not be required.

Section 2:

THAT the Ordinance Amendment, after its passage and approval, shall be published in pamphlet form and shall be in full force and effect on January 1, 2022, after such publication, in the manner, form and time as provided by the laws of the State of Illinois.




