ORDINANCE NO. 772

**AN ORDINANCE AUTHORIZING THE SALE
OF SURPLUS PROPERTY
OWNED BY THE VILLAGE OF WARRENSBURG, ILLINOIS**

WHEREAS, in the opinion of the corporate authorities of the Village of Warrensburg ("Village"), it is no longer necessary or useful to, or for the best interests of the Village, to retain the property described in Section 2 and Section 3 below; and

WHEREAS, it is in the best interest of the Village to expeditiously dispose of the property set forth in Section 2 and Section 3 pursuant to the authority granted to the Village by the Illinois Municipal Code, 65 ILCS 5/11-76-4 (2011).

NOW, THEREFORE, IT IS HEREBY ORDAINED by the President and the Trustees of the Village of Warrensburg, Macon County, Illinois:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

Section 2. Disposal 2003 Ford F550. Pursuant to Section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4, the Village finds, that continued ownership is no longer necessary or useful to the Village, or for the best interests of the Village to retain ownership of its 2003 Ford F550 truck, VIN 1FDAF56S23EC65868, and attached equipment.

Section 3. Disposal of Road Grader. Pursuant to Section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4, the Village finds that continued ownership is no longer necessary or useful to the Village, or for the best interests of the Village to retain ownership of its Alee Industrial Products, Model 51000, Serial No. 16931 Road Grader.

Section 4. Sale of Ford Truck and Road Grader. The Ford Truck and Road Grader set forth in Sections 2 and 3, respectively above, shall be sold "as is", after advertising the truck and road grader for sale in social media, any publication of general circulation in Macon County, Illinois and as otherwise determined in the best interest of the Village, to the highest bidder or bidders, with a \$3,000.00 reserve set on the road grader and a \$10,000.00 reserve set on the Ford F550.

Section 5. The Village shall accept sealed bids, to be received in the Village Hall on or before March 7, 2022 at 2:00 p.m.. The chairperson of the Streets Committee, or his designee, shall publicly open all sealed bids at 5:00 p.m. on March 7, 2022 at the Village Hall.

Section 6. The Village President being is hereby authorized to execute and deliver a Bill of Sale for each item, in a form as substantially set forth attached hereto as Exhibit A.

Section 7. Severability and Repeal of Inconsistent Ordinances. If an section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Warrensburg are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

Section 8. Effective Date. The Village Administrative Clerk of the Village of Warrensburg shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.






