**AN ORDINANCE AMENDING SECTIONS
332-53, 332-56, 332-64, 332-67 AND 338-2 C
OF THE VILLAGE CODE**

WHEREAS, the Village adopted Ordinance No. 768 establishing the Village of Warrensburg, Illinois Purchasing Policies and Procedures on November 15, 2021; and

WHEREAS, a review of the current Village Code indicates that there are inconsistencies in the Code with respect to the authority of various Village officials as to the officials' authority to incur expenditures; and

WHEREAS, it is desirable that there be consistency throughout the Village positions.

NOW, THEREFORE, be it ordained by the President of the Board of Trustees of the Village of Warrensburg

Section 1: Existing § 332-53 entitled "Expenditures." be and is the same is hereby deleted in its entirety and new language be inserted to read as follows:

Section § 332-53 Expenditures.

The Director of Public Works shall have the authority to incur expenditures in accordance with the Village's current Purchasing Policies and Procedures.

Section 2: Existing § 332-56 entitled "Authority." be and is the same is hereby deleted in its entirety and new language be inserted to read as follows:

Section § 332-56 Authority.

The Sewer Superintendent shall have the authority to incur expenditures in accordance with the Village's current Purchasing Policies and Procedures.

Section 3: Existing § 332-64 entitled "Expenditures." be and is the same is hereby deleted in its entirety and new language be inserted to read as follows:

Section § 332-64 Expenditures.

The Water Superintendent shall have the authority to incur expenditures in accordance with the Village's current Purchasing Policies and Procedures.

Section 4: Existing § 332-67 entitled "Authority." be and is the same is hereby deleted in its entirety and new language be inserted to read as follows:

Section § 332-67 Authority.

The Streets and Alleys Superintendent shall have the authority to incur expenditures in accordance with the Village's current Purchasing Policies and Procedures.

Section 5: Existing § 338-2 entitled "Chief of Police" "C. Authority." be and is the same is hereby deleted in its entirety and new language be inserted to read as follows:

Section § 338-2 Chief of Police.

C. The Chief of Police shall have authority to incur expenditures in accordance with the Village's current Purchasing Policies and Procedures.

Section 6: THAT this Ordinance, after its passage and approval, shall be published in pamphlet form and shall be in full force and effect on February 7, 2022, after such publication, in the manner, form and time as provided by the laws of the State of Illinois.


