ORDINANCE NO. 778

**AN ORDINANCE SUSPENDING THE NATIONAL POLLUTANT
DISCHARGE ELIMINATION SYSTEM (NPDES)
WASTEWATER SERVICE CHARGE**

WHEREAS, the Village of Warrensburg, Illinois (Warrensburg) did previously establish a National Pollutant Discharge Elimination System (NPDES) charge of Eighty Four Cents (0.84¢) per month per residential meter and One Dollar and 65/100 (\$1.65) per month per commercial, industrial institutional or governmental meter for the purpose of paying the EPA NPDES permit fee; and

WHEREAS, Warrensburg has collected sufficient sums in order to pay the current and additional permit fees for the foreseeable future; and

WHEREAS, it is necessary and desirable to suspend the monthly meter charges.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT OF THE BOARD OF TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:

Section 1: The National Pollutant Discharge Elimination System (NPDES) wastewater sewer charge of Eighty Four Cents (0.84¢) per month per residential meter and the NPDES charge of One Dollar and Sixty Five Cents (\$1.65) per month per commercial, industrial, institutional or governmental meter, be and is hereby suspended until further action by the Board of Trustees.

Section 2: Annually, the Warrensburg Finance Committee shall review the current and anticipated NPDES permit fees charged to the Village and report to the Board of Trustees concerning the issue of the continued suspension of the NPDES wastewater meter charges.

Section 3: That this ordinance, after its passage and approval, shall be published in pamphlet form, and shall be in full force and effect on October 3, 2022, after such publication, in the manner, form and time as provided by the laws of the State of Illinois.






