ORDINANCE NO. 781

**AN ORDINANCE AUTHORIZING THE SALE
OF SURPLUS PROPERTY
OWNED BY THE VILLAGE OF WARRENSBURG, ILLINOIS**

WHEREAS, in the opinion of the corporate authorities of the Village of Warrensburg ("Village"), it is no longer necessary or useful to, or for the best interests of the Village, to retain the property described in Section 2 below; and

WHEREAS, it is in the best interest of the Village to expeditiously dispose of the property set forth in Section 2 pursuant to the authority granted to the Village by the Illinois Municipal Code, 65 ILCS 5/11-76-4.

NOW, THEREFORE, IT IS HEREBY ORDAINED by the President and the Trustees of the Village of Warrensburg, Macon County, Illinois:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

Section 2. Disposal of 2010 Chevrolet Tahoe SUV. Pursuant to Section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4, the Village finds, that continued ownership is no longer necessary or useful to the Village, or for the best interests of the Village to retain ownership of its white 2010 Chevrolet Tahoe SUV, VIN GNMCAE00AR188255, and attached equipment.

Section 3. Sale of Chevrolet Tahoe SUV. The Chevrolet Tahoe SUV set forth in Section 2 above, shall be sold "as is", after advertising the SUV for sale in social media and any publication of Illinois statewide circulation for municipalities, governmental bodies, and units of local government and as otherwise determined in the best interest of the Village, to the highest bidder, with a \$13,000.00 reserve, conditioned upon the successful high bidder being authorized by law to use the equipment remaining on the SUV.

Section 4. Sealed Bids. The Village shall accept sealed bids, to be received in the Village Hall on or before January 30, 2023 at 2:00 p.m.. The chairperson of the Police Committee, or his designee, shall publicly open all sealed bids at 4:00 p.m. on January 30, 2023 at the Village Hall.

Section 5. Bill of Sale. The Village President is hereby authorized to execute and deliver a Bill of Sale for the SUV, in a form as substantially set forth attached hereto as Exhibit A.

Section 6. Severability and Repeal of Inconsistent Ordinances. If a section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Warrensburg are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

Section 7. Effective Date. The Village Administrative Clerk of the Village of Warrensburg shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.




